**ORDER**

**Whereas**, complaints are being received from various corners in regard to excess collection of School Admission fees by some Head of Schools of the State without prior approval of competent authority, in violation of Govt. order No. EDA.338/2020-21 dtd. 30<sup>th</sup> July, 2020.

**And whereas**, in the above mentioned order, all the Head of Schools were directed to strictly adhere to the Government prescribed School Admission fee norms (i) Classes IX to XII @ Rs. 120/- (ii) AISS/AISSCE (Internal) Board Examination fee @ Rs. 100/- per students per annum (iii) CBSE prescribed fees. No fees other than mentioned above were allowed to be collected from the students.

**Now therefore**, it is once again reiterated that all DDSEs and Head of Schools to strictly act in accordance with the Govt. order dated 30<sup>th</sup> July, 2020, and no excess fees shall be collected from the students beyond the prescribed limit of admission fees given in the said order. If, any Head of Schools has collected admission fees more than prescribed limit, the same will be refunded immediately to the respective parent/student as the case may be.

If any violation of the said order comes to the notice of the Head of Department, strict action shall be initiated against the concerned DDSE and Head of School as per rules.
